### About the Covington Parks and Recreation Fee Waiver Program

The fee waiver program allows children to participate in a Covington Parks and Recreation athletics program who, due to financial limitations, otherwise would not be able to participate.

#### Guidelines

1. A fee waiver is only available for youth ages 2-17.
2. A fee waiver may only be applied towards a maximum of 50% of the cost of any applicable registration.
3. Applicant shall provide proof of participation in a reduced school lunch program or equivalent proof of financial limitations.
4. The fee waiver application must be submitted and approved prior to any fee waiver being available for registration.
