Each membership may be purchased for a 3-month term, or 12-month term. The 12-month term memberships may be paid in monthly installments and has the option for automatic renewals.

Allow the member(s) to attend Lap Swims, Family Swims, Public Swims, and other similar drop-in swims. (Does not include special events, instructor/coach led activities, or activities requiring registration.)

Terms and Conditions

A. Memberships

- Members agree to pay the City of Covington a membership fee for the duration of this agreement. This membership is non-transferable, and the primary member is liable for the financial obligation of this Agreement regardless of whether or not they utilize the facility and/or programs. Members will not be credited due to lack of use of the facility or unavailability of the facility due to any routine or emergency maintenance or City recognized holidays, but memberships will be extended for facility closures longer than 2-days (48 hours) for an equivalent length in time. Members will not be credited due to the facility not being available due to the maximum occupancy having been reached.

_____ Initial

B. Fee/Payments

- 3-month Memberships:** Members agree to pay the City of Covington the 3-month membership fee in full on or before the first day the membership begins.
- 12-month Memberships:**
 - Members agree to pay in full the 12-month membership fee on or before the first day the membership begins; or
 - Members agree to pay the 12-month membership fee in 12 equal installments (within \$0.11).
 - For members that agree to automatic renewals, the bank/credit card drafts will be continuous.
 - Monthly payments will be deducted/charged on the 5th of each month with payment automatically charged to your bank/credit card. Members agree to notify Covington Aquatic Center of any bank/credit card account changes that would prevent or prohibit timely payments.

Terms and Conditions (continued)

C. Facilities Use and Rules

_____ Initial

1. In consideration for such payment, members shall be entitled to use facilities/programs included in the specific type of membership selected. Use of the facility and participation in programs is at the member's own risk
2. Use by all members shall be subject to the rules, regulations, and facility/program schedule of the Covington Aquatic Center. Memberships may be suspended or cancelled for violation of the rules and regulations of the Covington Aquatic Center and program schedules may change.
3. All membership cards must be presented to front desk personnel and scanned upon each visit.
4. Covington Aquatic Center and the City of Covington are not responsible for any lost or stolen items.

_____ Initial

D. Membership Holds

1. Holds may be placed on any 3 month or 12 month memberships for a minimum of 14 days and a maximum of 3 months per calendar year, for any reason. Member's requests must be submitted in writing at least 30 days prior, with a limit of 2 per calendar year. There is a \$5.00 holding fee for each membership "hold" transaction.

E. Miscellaneous Fees

_____ Initial

1. A \$5.00 fee will be charged to replace a lost or stolen membership card.
2. A \$40.00 fee will be charged for any monthly withdrawal not honored by the primary member's bank because of non-sufficient funds (NSF)

F. Fee Changes

_____ Initial

1. All fees rates included in this agreement are subject to change. Members will be notified by email of any changes in membership fees at least 60 days prior to the fee change taking effect. It is the responsibility of the member to notify Covington Aquatic Center of any changes in the member's email address.

G. Requests for Cancellations, Amendments, or Holds

_____ Initial

1. All requests for amendments or holds, must be submitted in person in writing at least 45 days prior to the date the member is requesting the amendment or hold be effective.
2. All requests for cancellation of memberships must be submitted in writing and will be cancelled within a week of receiving the amendment form. Cancellations to the contract will be assessed a fee equal to two months payment.

H. Waiver and Release from Liability

_____ Initial

1. **Release and Hold Harmless Agreement:** Members agree to indemnify, release, and hold harmless the City of Covington, all of its officers, agents, volunteers, and employees, from any and all liability for injury, claims, costs, loss or damage to persons (including death) or property, that result from, arise out of or are in any way, directly or indirectly, connected with the use of City of Covington owned facilities, City of Covington sponsored events or programs or that may be the result of or related in any way to any negligence or other acts or omissions of the City of Covington, its officers, agents, employees or volunteers.
2. **Photograph and Video Permission:** Members grant full permission to use any photographs, video tapes or any other record which may include image or audio for any City of Covington informational or promotional use. Members agree to these terms on behalf of, and they are binding on the member, the member's family and heirs, beneficiaries, personal representatives and estate.
3. **Property Loss:** The Covington Aquatic Center and the City of Covington are not responsible for personal property lost, damaged, or stolen while members and/or program participants are using the Covington Aquatic Center or participating in Covington Aquatic Center program.
4. **Insurance:** It is the member's responsibility to provide their own (and other members of their family if applicable) accident and health coverage while participating in all Covington Aquatic Center programs. The Covington Aquatic Center and the City of Covington does not provide accident or health insurance for its participants.
5. **Medical Release:** Members authorize the Covington Aquatic Center, as their agent, to give consent for medical treatment by a licensed physician or hospital when such treatment is deemed necessary by the physician and the member's emergency contact(s) cannot be contacted within a reasonable time or otherwise unable to give such consent. Members authorize the Covington Aquatic Center to give first aid, CPR or other treatment by qualified staff members. Limitations which may interfere with emergency treatment: medications, allergies, chronic illnesses, surgeries, drugs, etc. Attach additional page if needed.
