

**CALL FOR BIDS
CITY OF COVINGTON
156TH AVENUE SE REHABILITATION PROJECT**

Sealed Proposals will be received by the undersigned at the City of Covington, 16720 SE 271st Street, Suite 100, Covington, Washington 98042, up to 10:00 a.m. local time on September 8th, 2014 for furnishing the necessary labor, materials, equipment, tools, and guarantees thereof to construct 156th Avenue SE Rehabilitation project.

This contract provides for the rehabilitation and resurfacing of 156th Avenue SE from SE 272nd to SE 261st. Total project length is approximately 3,900 lineal feet. The improvements include, but are not specifically limited to, pulverization, grading, asphalt paving, channelization, traffic control, and other miscellaneous items as further shown, described, and indicated in the Contract Documents.

The Work shall be physically complete within 20 working days after the commencement date stated in the Notice to Proceed. All bidding and construction is to be performed in compliance with the Contract Provisions and Contract Plans for this project and any addenda issued thereto that are on file at the office of the City Clerk, City Hall, Covington, Washington.

The Proposals will be publicly opened and read aloud shortly after the time and date stated above. Proposals are to be submitted only on the form provided with the Contract Provisions. All Proposals must be accompanied by a certified check, cashier's check, money order, or bid bond payable to the "City of Covington" and in an amount of not less than five percent (5%) of the total amount bid.

The City of Covington in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 USC 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-Assisted Programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises as defined at 49 CFR Part 26 will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, national origin, or sex in consideration for an award.
